Dear Ringette Parents and Players:

A reminder that **Early Registration** for the 2010/2011 season will begin, on-line, **Tuesday June 1st** and close **Wednesday June 30th**.

- After June 30th returning players registering in the 2010/11 season will be required to pay the higher registration fees. This includes players who requested refunds and didn't play for part or all of a previous season. Cash/Cheque (for on-line registrations) payments **must be received in full to the MSA office by July 8th for early registration rates to remain valid.**

ADDITIONAL FEES

- **Fundraising**
 - Grey Cup Tickets \$ 50.00 per player
- **Pre-season Camp (optional)** \$ 50.00 per player (4 ice times all levels)
Pre-season training camp will **NOT** be used for evaluations and/or tiering.
- **Participation Cheque** \$ 200.00 per family
(Post dated March 1, 2011 and hand to team manger once teams are made)
 - Cashed only if mandatory 10 hours not completed by end of season. *See below.

*The Participation Cheque collected at registration is to ensure that every family supports the FSRA in fundraising and volunteer activities. Some examples of ways to earn participation hours for the FSRA are:

- working a casino or Oilers 50/50 if available
- working the concession at the Hawks games
- working on a committee, tournament, fundraising

- **working the provincial tournament**
- **coach, assistant coach or manager of a team**
- **becoming a member of the executive**
- **special projects**

A \$200.00 participation cheque will still be required at the start of the season. A cheque will only be cashed in the event the full 10hrs of participation are not met. In these instances required participation hours will be decided by the Fundraising Director.

All returned cheques will be assessed a \$35.00 charge

REFUND POLICY

Pre-season camp will be refunded if player did not participate **at all**. There will be no partial refunds for pre-season camp. The refund policy consists of a percentage of the **registration fee only** being returned. The breakdown is as follows:

- **withdraw by August 31 – 90 % reg fee refunded (less \$20 processing fee)**
- **withdraw by September 15 – 75% reg fee refunded (less \$20 processing fee)**
- **withdraw by November 15 – 50% reg fee refunded (less \$20 processing fee)**
- **withdraw after November 15 – no refund**

All players are required to wear Association approved ringette pants and jerseys for games. You will be able to order FSRA pants from jscarnell@shaw.ca

Any request for specific placement of your child must be received in writing using the player request form located on our website and given to the player/coach development director or division coordinator prior to team evaluations/selections. All requests will be considered individually by the Director/Executive.
